The notice dated 10th February 2025 convening the Postal Ballot process, as confirmed by the Company, was sent to the shareholders in respect of the below mentioned resolutions passed by way of Postal Ballot process through the electronic mode to those members whose e-mail addresses are registered with the Company/Registrar and Transfer Agent/ Depositories/ Depository Participants in compliance with the MCA Circular dated September 19, 2024, read with the Circulars dated September 25, 2023, December 28, 2022, May 05, 2022, December 14, 2021, January 13, 2021, May 05, 2020, April 13, 2020 and April 8, 2020, and the relevant SEBI circulars.

The Company had availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting by the shareholders of the Company prior to the Meeting as well as during the Meeting.

The Voting period for remote e-voting commenced at 9:00 A.M on Wednesday, 19th February 2025 and ended at 5:00 P.M on Thursday, March 20, 2025, and the CDSL e-voting system was disabled thereafter.

Shareholders of the Company holding shares as on the "cut-off" date of Friday, 14th February 2025 were entitled to vote on the resolutions as contained in the notice of the Postal Ballot.

After the closure of remote e-voting, the votes cast under remote e-voting facility were unblocked and counted.
